1. These Regulations may be cited as

**Short title.**

**THE SOCIAL SECURITY (COLLECTION OF  
CONTRIBUTIONS) (AMENDMENT)  
REGULATIONS, 2000**

and shall be read and construed as one with the Social Security (Collection of Contributions) Regulations which, as amended, are hereinafter referred to as the principal Regulations.

2. Regulation 6 of the principal Regulations is hereby amended as follows:

**Amendment of  
regulation 6.**

(1) in subregulation (1) thereof, by substituting the words, "three hundred and twenty dollars" **for** the words "one hundred and thirty dollars" occurring therein;

(2) in subregulation (2) thereof by substituting, "two dollars and sixty cents" **for** the words "one dollar and fifty cents" occurring therein.

**Repeal and replacement  
of Schedule.**

3. The schedule to the principal Regulations is hereby repealed and replaced by the Schedule to these Regulations.

**Commencement.**

4. These Regulations shall come into force on the 01 day of January, 2001.
