and shall be read and construed as one with the Social Security (Non-Contributory Pension for Women 65 Years or Over) Regulations, which, as amended, are hereinafter referred to as the principal Regulations.

2. Regulation 3 of the principal Regulations is amended in paragraph (b) by deleting the phrase “permanent resident or”.

3. Regulation 3A of the principal Regulations is amended in paragraph (a) by deleting the phrase “or a permanent resident”.

4. The principal Regulations is amended by inserting immediately after regulation 3A, the following as regulation 3B-

“Restriction
on
entitlement

contributory
pension.

3B. A non-contributory pension shall only be payable to oneregistered female person or registered male person of a household.”.

Savings and
transitional.

5.-(1) Notwithstanding clause 3 every registered female person who is a permanent resident of Belize and is receiving a non-contributory pension before the entry into force of this amendment Regulations, shall continue to be paid a non-contributory pension.

(2) Notwithstanding clause 4 every registered male person who is a permanent resident of Belize and is receiving a non-contributory pension before the entry into force of this amendment Regulations, shall continue to be paid a non-contributory pension.

(3) Notwithstanding clause 5, every registered male person and registered female person of the same household receiving a non-contributory pension before the entry into force of this amendment Regulations, shall continue to be paid a non-contributory pension.

6. These Regulations are subject to negative resolution.
