LUMP SUM PAYMENT.**



## SOCIAL SECURITY'S FUNERAL GRANT PACKAGE

(Offered as an alternative to \$1,500 lump sum payment)

Social Security notes the importance of providing a helping hand in times of need. Upon the death of a loved one, the family looks for a dignified manner to lay their loved one to rest.

To assist families during this period of bereavement, the Social Security Board in collaboration with Homeland Development Ltd. offers the following Funeral package as an alternative option:

## FUNERAL GRANT PACKAGE

- An underground cement burial plot at Homeland Memorial Park located at Mile 8 on the George Price Highway.
- A pine lumber or plywood wooden casket with sealed varnish, lining, handles and lid.
- A hearse to transport the coffin and the deceased from any church in the Belize City vicinity to Homeland Memorial Park for interment services.
- All equipment and personnel needed to place the deceased underground and to construct/place the cement lid on the crypt.

## IMPORTANT NOTES

- The package is offered to Insured Persons who qualify for the Funeral Grant.
- Transportation (Hearse) is limited from Belize City only to Homeland Memorial Site at Mile 8 on the George Price Highway.
- A contract must be signed, and the claimant must submit the signed contract to Homeland Development Ltd. within 24 hours of approval.
- Homeland Memorial requires 24 hours' notice to prepare the site.
- Tombstone and/or any other services desired that are not part of the package may be arranged through Homeland Memorial Ltd.
